Riverside Drive directly across the street from the Pompano Beach City Parking Lot where your car should be parked. There is a parking fee of \$1.00 an hour (estimate 21/2 hours for the tour). A one year membership is \$25.00 for an individual, \$35.00 for a family or \$50.00 for an organization or business. These memberships allow you to attend any tour or

vity for a full year with no additional fees except for any meals or very special activities.


After checking in at the dock, you will receive a wrist band and wait for the chartered boat that will shuttle to and from the Light Station beginning at 9:00 A.M. with the last trip to the Lighthouse approximately between 2:45 and 3:00 P.M. The Station closes at about 4:30 P.M.

The highlight of your tour will be climbing the Lighthouse stairs to enjoy the 360 degree spectacular views. The Truth at Hillsboro Inlet, FL and The False at St. Louis, MO

Sometimes a falsehood is repeated so often that even historians get it wrong. That is the case with the building of Hillsboro Inlet Lighthouse. Hillsboro Inlet Lighthouse tower was constructed by the Russel Wheel & Foundry Co. in Detroit, Michigan in 1906. It was disassembled (in April 1906) and shipped by steamer from Detroit thru the Great Lakes, Illinois & Mississippi Rivers and into the Gulf of Mexico to Southeast Florida.


The false account states that Hillsboro Inlet Lighthouse tower was built in Chicago in 1903 and shipped by steamer to St. Louis for display at the 1904 World's Fair and afterwards disassembled and sent down the Mississippi River by barge to Hillsboro Inlet, Florida in 1907.

The truth is that at the 1904 Fair, also called The Louisiana Purchase Centennial Exposition, was a large model, 60 ft. tall shown above at the right. Perhaps Hillsboro's beautiful lens manufactured in Paris, France was on display in the same Great Room. We do no know any other way the model lighthouse on the right could be mistaken for the Hillsboro Inlet Lighthouse manufactured in another city two years later.

The picture of the model at the right was taken from a book titled *Inside The World's Fair Of 1904*, volume one by Elana V. Fox. The picture on the left of Hillsboro Inlet Lighthouse came from Florida Photographic Archives in Tallahassee. See the comparison.



The Keepers of the Old U.S. Light House Service from 1820 - 1939



Light keepers were paid an average of \$600 a year with the principal keeper receiving much more and the assistant keepers receiving much less. Each keeper was furnished with quarters for themselves and their families. Boats were provided for stations inaccessible to land as Hillsboro was from 1907-1920s. A teacher was also provided for the children. However, dress and fatigue uniforms for keepers were introduced in 1883 and although required, became the keeper's personal cost.

Mr. Hurley tells us that the discipline of the Service was rigid. It was the duty of every keeper to stand by his light as long as the lighthouse stood. "For him to desert it when it was in danger was as cowardly as for a soldier to leave his guns on the advance of an enemy". If any keeper was found intoxicated, he was to be dismissed from the Service and instantly ejected from the station. A keeper who allowed his light to go out was dismissed without considering any excuse or his previous good conduct. Thomas Jefferson had said when he was President, "Keepers of light-houses should be dismissed for small degrees of remissness because of the calamities which even these produce". By 1894 "the class of men from whom keepers were selected was so good that the punishment of dismissal was infrequently inflicted".

It was no part of the lighthouse keeper's duty to take to the sea to save survivors of wrecks, but many did. In those cases when they endangered their own lives, "they received from the Secretary of the Treasury gold or silver medals in proportion to the danger incurred, not as compensation, but rather as marks in appreciation for their services".

The HLPS staff in turn thanked the USCG Auxiliary and the USCG Aids to Navigation


